Equine and Animal Law is a highly specialised area. Whether horses or animals are your business or hobby, there is undoubtedly a potential minefield of risks.

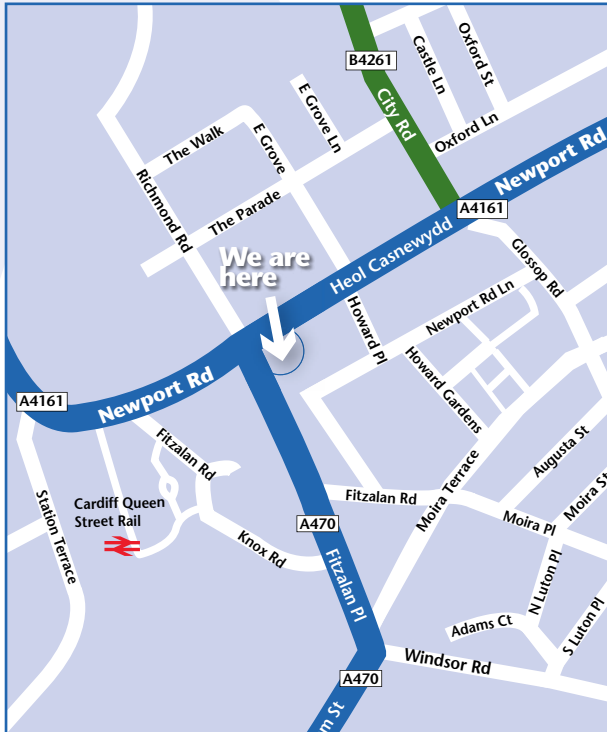
