- Private medical treatment

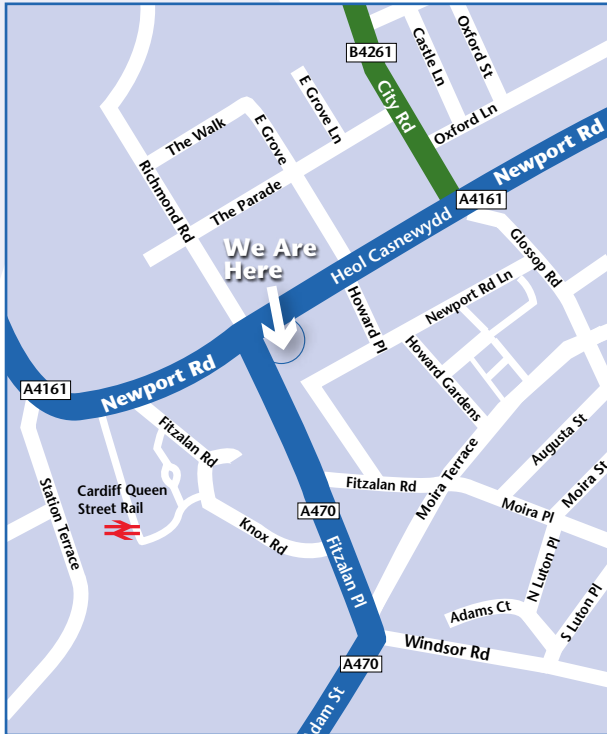
- Cost of care
